



## **BASES OF THE CALL OF THE CONTEST FOR PAINTING A MURAL ON THE DIVIDING WALL OF BON VIATGE Nº2 BUILDING FOR THE CONMEMMORATION OF THE YEAR JULOL140.**

### **First.- Object.**

The purpose of these guidelines is to regulate and state the criteria and the procedure of application, processing, grant and payment of the Contest's award on the project of painting a big dimensions wall in Sant Joan Despí, Barcelona (Spain).

This mural project will be related to the year Jujol140, an artistic, cultural and social movement to promote Josep Maria Jujol's figure and the city of Sant Joan Despí, coinciding with the 140 anniversary of the birth of the architect, one of the references on Catalan modernism, author of the architectonic jewels Can Negre or Torre de la Creu, in Sant Joan Despí, o Metropol Theatre, in Tarragona. The mural's artwork must therefore be related to Jujol's figure.

We understand as mural painting every artwork created on an architectonic support and that is plastically and symbolically related to its urban environment.

### **Second.- Participants.**

Natural persons of legal age and legal entities that have full operating capacity can participate. In the case of legal persons it must be designated the author and performer of the mural that will be, if applicable, the one finally designated. Any person age 18 or older can participate, regardless of nationality or country of residence.

### **Third.- Concession procedure**

The concession procedure of the grant will be in competitive concurrence.

### **Fourth.- Budgetary appropriation**

The payment of the grant is budgetarily consigned through the 01.336.489 application in the municipality's budget of 2019.

### **Fifth.- Inscription and terms of submission of applications.**

In order to carry out registration it will be required to complete the form attached to this document that can also be downloaded from the website [www.sjdespi.cat](http://www.sjdespi.cat).



The application's submission must be done through telematic channel (E-tram) or personally at the Municipality's citizen attention office.

Together with the form, it will also be required to present a digital portfolio up to 10 pages clearly showing experience in large scale murals.

Likewise, it will be necessary to provide the documentation that proves the personality of the applicant: photocopy of the DNI, NIE or passport.

In the information sent, the names of the attached documents should have the following format: *Artist's Name\_inscripció.pdf* and *Artist's Name\_Portfoli.pdf*

The entire registration process (presentation of the form, portfolio, etc.) must be completed within the deadline for submission. Under no circumstances will late registrations be accepted.

The term of registration of applications will begin the day following the publication of this call in the BOPB and will end on May 7, both included.

It is not necessary to attach an outline proposal in the first stage, presenting this document is optional.

The final proposal of the winning or winning artist will be presented at the latest on September 1, 2019 at the Sant Joan Despí Town Hall to carry out its evaluation. The City Council will have the option to reject the work if it does not comply with the fees established by these bases or the assessment commission. As well as request a second proposal.

#### **Sixth.- Rectification of defects or omissions in the documentation.**

In case the submitted documentation is incorrect, or incomplete, the applicant will be required to proceed, within ten working days from the day following the notification, to rectify or incorporate the necessary changes. In case it is not corrected, the fault within this term will be understood as dismissed from the request.

#### **Seventh.- Valuation Committee**

The composition of the assessment committee will be:

- President of the Person Services Area of the Sant Joan Despí City Council.
- Head of the Cultural Services Department of the Sant Joan Despí City Council.
- Municipal Coordinator of Any Jujol140.
- Technician of the urban planning service of the Sant Joan Despí Town Hall.
- Curator of the Contorno Urbano Foundation.

The community of neighbors who own the façade will give their opinion about the presented artists so that it can be valued by the professional jury.

The assessment committee will jointly examine, in a single procedure, all the applications submitted within the established term and will be resolved in a single administrative act.

The jury will act collegiate in its decision, which will be taken by the majority of votes.

A member of the evaluation committee will act as secretary and will draw up an act that will be signed by all members and where the verdict will be recorded.

The decision of the jury will be recorded in a public act, will be unappealable and not subject to appeal.

#### **Eighth.- Valuation and selection criteria**

The evaluation of the jury will be made taking into account the following criteria:

1. The curricular trajectory and / or academic training. (1-5 points)
2. Participation in exhibitions, events, festivals and exhibitions. (1-5 points)
3. Originality and creativity in the approach and / or development. (1-5 points)
4. Obtaining scholarships, prizes and residences during the artistic career of the finalist. (1-5 points)
5. Continued work in the realization of murals in the public space. (1-5 points)

#### **Ninth.- Resolution, notification and regime of resources**

The evaluation committee will evaluate the artists that submit the application and will select a single winning artist to carry out the execution of the artwork.

The decision of the jury will be raised in the form of a proposal from the mayor's office in the Local Government Board, the competent body to agree on the approval of the prize award.

The resolution of the prize award will be notified through the board of edicts.

The resolution of the procedure puts an end to the administrative procedure and against it, a contentious administrative appeal can be filed within two months from the day following its notification. Alternatively and optionally, an appeal for reconsideration may be filed with the same body that issued it within one month of the day following its notification.

### **Tenth.- Acceptance of the prize**

It will be understood the prize to be tacitly accepted by the beneficiary for one month from the notification of the concession without expressly stating his objections. In any case, the subsidy will be considered accepted without reservations, as well as the conditions imposed in its concession.

### **Eleventh.- Conditions and prohibitions**

- These murals cannot have been painted with materials of low durability such as aerosols or ephemeral. The technique that will be used in the elaboration of the mural will be the application of high-quality sol-silicate paint to guarantee a duration of the work in the best possible conditions for more than 30 years. For this reason, murals made only with aerosols of any kind will not be taken into account when assessing the artist, since it is not the technique nor the material that will be used in the mural. The presentation of murals with plastic paints, sol-silicate, etc. will be positively valued, applied with any technique.
- The projects of the murals to be made must be unpublished and, therefore, cannot be currently painted on other walls of any place on the planet.
- Work will not admit the content of which threaten or violate human rights, promote violence, or discrimination based on sex, race or any other type of discrimination.
- The organization will decide the timetable for the completion of the work, with an estimated date between September 1 and 30, 2019.

The fact of participating in the contest will imply:

- Knowledge and full acceptance of these rules and the decisions of the jury.
- That the selected artists cede, without exclusivity, the rights of reproduction, transformation and public communication or any other right provided in the current legislation on intellectual property to the City of Sant Joan Despí without time limit and worldwide. For the purposes of this assignment, transformation means the simple inclusion of the proposals submitted by the finalists and the winner's mural in publications, web pages and other communication channels that the City Council considers appropriate, as well as the public exposure of the proposals selected.

The participants are fully responsible for being the only authors and that there are no prior rights of third parties on the project submitted to the call.

### **Twelfth.- Prize and payment.**

The selected artist will receive a € 6,000 prize for the completed intervention.

Likewise, the necessary materials for the realization of the project will be provided and a photographic and video follow-up of the mural will be made.



The payment of the prize will be made in the following way:

- 50% from the notification of the award resolution and by bank transfer to the account number provided by the winner.
- 50% once the performance is completed by bank transfer to the account number provided by the winner.

The payment of all taxes, fees and / or surcharges, if any, arising from the awarding of the prizes, will be the sole responsibility of the winner of the prize.

### **Thirteenth.- Compatibility of the prize**

The prize awarded will be compatible with any other subsidy, aid or award granted by other administrations or public or private entities.

### **Fourteenth.- Justification**

Due to the very nature of the prize, it is not subject to a justification regime.

### **Fifteenth.- Protection of personal data**

In compliance with the General Regulation of Data Protection, from the City of Sant Joan Despí, as responsible for the treatment, we inform you that the personal data collected will be treated with the sole purpose of managing and disseminating the communication campaign of the commemorative mural Any Jujol. This treatment is legitimized by the unequivocal consent given by the participants when providing their data and by the exercise of public functions of the City Council.

You can exercise the rights of those interested in access, rectification, deletion, portability of data, limitation and opposition to the treatment addressed to your request, with a photocopy of your official identification document, in the General Register of the City Council - Office of Attention citizen in the direction Camí del Mig, 9, 08970 Sant Joan Despí or telematically through the electronic headquarters of the City Council <https://www.seu-e.cat/web/santjoandespi/seu-electronica>

### **Sixteenth.- Responsibility**

The organizer and the collaborating companies do not assume any responsibility for any error, omission, interruption, elimination, defect, delay in the operation or transmission, failures or technical malfunction of any telephone lines, online computer systems, servers, suppliers, equipment. computer, programmer, email or browsers, either due to technical problems, traffic congestion on the internet or on any website, or because of any combination of the above, or any other activity related to the contest (including, without limitation, any problem that makes it impossible for the participant to access the web or to send materials).



### **Seventeenth.- Advertising**

These bases will be published in full in the Official Gazette of the Province of Barcelona, with a review in the Official Gazette of the Generalitat de Catalunya, on the electronic bulletin board of the Sant Joan Despí Town Hall, which can be accessed from the electronic headquarters [www.sjdespi.net](http://www.sjdespi.net) and as many announcements as in the mass media and other informative supports, that favor their diffusion.

The agreements adopted in the granting procedure regulated by these specific Bases will have the effect of notification in accordance with the provisions of article 45.1.b) of Law 39/2015, of October 1, on the common administrative procedure of the public administrations.
